



The United Nations General Assembly assembled to formulate a draft resolution, the agenda being, "Discussing the Outer Space Treaty to counter militarisation and

technological threats in outer space". The air quivered as words sliced through it, causing a varied range of opinions and fortunately enough, solutions.



The start of the day dissolved into a series of speeches, as Finland began by quoting Nelson Mandela— "It is in your hands to create a better world for those who live in it."

"Committee will not progress until we realize who is at fault," Finland said. She urged the ban of Anti-satellites. "The past is the past, the future is unknown, but the present can be changed, it is in our hands," she stated. North Korea asked Finland how the latter could criticize others when the individuals in their community were mistreated. To this, Finland firmly said that it was ironic that North Korea was saying this since individuals in North Korea were mistreated for not having pictures of their leaders in their homes. Mexico emphasized the urgent need for international cooperation. She also stated that global security was being threatened by space militarisation.

Fortunately, Costa Rica managed to take the path which led to constructive solutions, instead indulging in pointing fingers. Portugal asked, "Was militarising the Earth not enough, that you are militarising space now?" Portugal was asked if

Portugal was putting their international relations with the United States of America above international cooperation.

"Domination of space is domination on Earth," New Zealand said. To which, Brazil asked about the condition of the citizens due to the floods that occurred the week before.

The United Arab Emirates stated that space was turning into a stage for competitors.

Everyone flocked together into separate groups as there began a buzz of discussions. Everyone prayed silently, waiting for the names of the first two draft resolutions received to be called out. "USA," a voice announced as a wave of excitement engulfed them. "India and Canada," the voice followed. Excitement was engulfed by disappointment from those whose names had not been called out.



The first draft resolution suggested steps to recognize the increasing complexity of space activities and the need for an updated framework. It further suggested the need to emphasize the necessity to prevent the arms race in outer space as a form of threat to Outer Space and disturbance of the ecological balance of space. It also suggested that one must keep in mind the growing threat of space debris.

However, it was brought to notice that there was a full stop before the solutions right after the signatories. This led to the entire resolution being scrapped which further resulted in an uproar.

India and Canada were co-authoring the next draft resolution. Instead of getting 36 signatories, there were only 31. USA was ordered to step out for a few seconds to be expressive of his eagerness.

The next draft resolution was brought forth by China and it was headed as "OH ZAALIMA". This led to an immediate uproar of excitement with glimmers of agenda. It was brought to notice that the agenda itself was not written. Everyone rose, banging tables, feeling an embrace of excitement.

Unfortunately, the day ended with a sentence of despair— "The committee has failed."

At the onset of the third day, the committee was looked forward to constructive debate, and a Draft Resolution. Australia began their speech by accusing the superpowers of playing the blame game and urged them to immediately stop doing so. Australia then proceeded to accuse the USSR for using its veto power 43 times in a span of less than 5 years. They raised two solutions for the problem — first was the reformation of the veto power in cases regarding genocides, atrocities are war crimes and second one being the introduction of a consensus based mechanism to help overcome such problems.

UNHGA

North Korea reminded us of previous findings discussed in committee and onsidered the attack an "unjustified act" by the western bloc and the NATO countries for they completely disregarded the international laws as well as the UN charter.



They urged the committee to come to a solution for the huge conflict and bring justice to the thousands of victims. Multiple nations felt that the council was dominated by western forces which would make it quite biased. USA suggested that the powers should be vested in the General Assembly in regards to what should be discussed in the Security Council. The US tried its very best to convince the members to vote for resolution 33AA. South Korea felt that the resolution had already been passed on the day before, however the Executive Board clarified that the resolution will be passed after voting. Iran suggested the committee to sign an agreement on nuclear disagreement so that new weapons are not developed, but this failed to make any significant impact among the nations. Czechoslovakia wondered how it will be ensured that none of the committees are secretly producing weapons and then Iran proposed the formation of an United Nations committee that will moderate the rest of the countries and make sure that none of them are producing any weapons. The nations were informed that two-third of the members of the committee should vote for the resolution for it to be discussed and instructed the authors to carry a list of signatures of their signatories to avoid any confusion.

With this, the committee began discussing resolutions. The delegates enthusiastically gathered to go through the resolutions. The resolutions were thoroughly detailed and well executed.



They were extremely attentive and full of energy. Fallacies were pointed out by the delegates. The Executive Board's table was overflowing with amendments from the delegates. The delegates were alert throughout the committee and noticed even the extremely intricate details in the resolutions as well as the speeches and raised intriguing questions. After three days of hard work and dedication of the delegates from all over the nation, and having discussed over five resolutions, the committee had unfortunately failed. However, we witnessed unity among the delegates and lifetime friendships were formed, thus fulfilling the main aim of LMC MUN 2024.

UNHSC

In today's committee, we started with the delegates of Nigeria. They made a statement very clear that people in Africa should be treated with quality calling for an end to apartheid and racial discrimination across the continent. Nigeria urged to take action to prevent the recurrence of such injustice and to uphold the rights of the individuals. Nigeria proposed equal rights to all African citizens. The developments of nuclear weapons indicate attacks directed at the USSR, with reports suggesting the use of chemical weapons in the Brazilian area. One main concern of these attacks was the impact of this on the population living on the west coast of South Africa.

The USA also deployed 50 troops raising questions about the intention behind this. The committee discussed addressing security concerns and facilitating the withdrawal of troops. There was a proposal to impose sanctions on South Africa to prevent further tests and explosions like the one at the Welfare Research Centre. Zimbabwe is urging the United States to stop supporting South Africa's arms development, as per Security Council Resolution 480. They also expressed concern about American involvement in Vietnam and reported missile sightings in Berlin, as well as missile testing in the Kalahari Desert.



Then there were resolutions. Despite numerous resolutions being discussed and voted on, the resolutions were failing. The session was filled with discussions and debates as delegates delved into topics, from serious to light discussions. Resolutions were proposed on issues such as "peace", the intriguingly named "Chili Chipi Chapa Chapa," "Cheesecake", "Maxxing", and even the hour of "3 am". Clauses were being scrapped during the discussions. There were also discussions about apartheid, with numerous "no" votes and abstentions. A second round of resolutions took place where the three resolutions were discussed in committee. Firstly, the committee discussed a resolution named "Blueberry Cheesecake" which the USA and France were the authors. Clauses four, nine, six, eleven, and ten were scraped, despite that the resolution was still standing. During the question-answer session of this particular resolution, the authors were thoroughly questioned by four nations in the committee including Angola. However in the end due to numerous "no" votes the resolution was scraped. Till the end the possibility of the next two resolutions passing was very high, but when it came down to voting unfortunately both of them failed. After three fruitful days full of intense debate and a number of resolutions, the committee had failed however the time in committee has been truly a learning experience!

BERLIN CONFERENCE

The committee started with a general speakers list where each party, the African polities and European nations, discussed what they wanted from the general act. They discussed the territories the Europeans wanted and the rights of the Africans to protect their territories. The delegates were then given about an hour to formulate, write, and submit the General Act. The General Act was signed by the United Kingdom, France, Germany, Austria, Belgium, Denmark, Spain, the United States of America, Italy, the Netherlands, Portugal, Russia, Sweden-Norway and Turkey (Ottoman Empire). The act consisted of twentyfour clauses. Article one of the first clause consisted of a list of African territories that were to be a part of the sovereign territory of the German Empire. Article 2 was the same but the African territories were to be a part of Belgium. The next few articles were the same but for the United Kingdom and Northern Ireland, Portugal, Spain, Italy etc. Out of these twenty-four clauses, seven clauses were scraped and there were two amendments, article sixteen and article twenty-one. There was then a 3v3 debate which was very fruitful and intense. However in the end, during voting, there were two "no" votes which led to the committee failing.



The last and final day of the committee and started off with speeches from different countries. The delegates were surely tired after two days of intense debate and paperwork but the excitement was at an all-time high as it was the day the delegates would come up with a feasible resolution for solving the crisis. An interestingly polarising speech ended with the words, "The KLA is a leech who is sucking blood from Kosovo and there should be immediate action taken to neutralize them ." Then the committee transitioned into discussing about various issues regarding the crisis of Pristina and the abducted children and the demand for independence of workers in Kosovo. The committee at each step was full of ambiguity and excitement.

OSCE -

At this juncture, the committee came across news that on 1st November, 1998, the US and UK formed a bilateral intelligence agency known as the Corleone Force Framework. This force was sent to Yugoslavia, focusing on unearthing crimes committed by Yugoslav security forces. However, they found out something more horrific--the KLA was found perpetrating heinous acts against humanity, including bombings and brutal attacks on Serbian civilians and villages. One in every ten KLA soldiers was from Russia. Thus heated arguments ensued and some laughs along the way.



The discussion that followed kept everyone on their toes and challenged the delegates. The dirty blame game continued to prevail as it does in OSCE with all the blame being pinned onto one country, intensifying the situation further. As they say, "Russia is a riddle wrapped in a mystery inside an enigma." A delegate used his dramatic skills quite well and expressed his hatred and sorrow towards their biggest ally. Certain delegates were convinced that this 'live actor' was doing nothing except playing the 'victim card'; and yet again there was an important development. It truly became a 'crisis committee'. The polarised committee formed two bands before further discussion.

The attention of the committee then turned to the one last explosive development. Sources stated that Sluzhba Vneshney Razvedki, the Foreign Intelligence Service of Russia launched an operation called 'Operation Fein' carried out by 4 agents. The sources stated that KLA is strictly abiding by the commands of the US, Hungary and Denmark to assure its autonomy. USA, Denmark, and Hungary cleared that they will not engage with KLA.

Then it was time for the much awaited event, discussing the draft resolution. Several draft resolutions came into picture including the Draft Resolution 2.0, Draft Resolution 4.2, Draft Resolution Jungus, Draft Resolution Messiah, Draft Resolution Money Trees and out of which Draft Resolution Money Trees was passed by majority. After much debate, consensus and friendly competition the draft resolution was decided upon by majority yet again showcasing the collaborative spirit of OSCE but alas the preambles were sadly scrapped. The resolution did not contain the agenda! It was indeed a very careless mistake. After much consideration and deliberation the whole resolution was scrapped.

The committee struggled to get a majority of votes and this was proving to be worrisome for the committee. With this we came down to the final hour of the committee. The chair had no choice but to declare that the committee in reality had failed. And even though the committee had failed, all the delegates will surely remember this committee for the rest of their lives. From friendly fights to blame gaming, the committee was truly dynamic and with this OSCE comes to and end. As Harvey Specter once said and I quote, "That's the difference between you and me, you want to lose small, I want to win big" and truly all of us in committee felt like we won something today.

With this the committee comes to an end with heavy hearts and fruitful conversations.


